Maximum users are found satisfied with the physical facilities and collection as well as arrangement of library reading material.

# INTRODUCTION

On July 23, 2010 Maharashtra Legislative Assembly passed a unanimous resolution to constitute the Gondwana University, for the area comprising districts of Chandrapur and Gadchiroli.[1] The resolution was moved by then Higher and Technical Education Minister <u>Rajesh Tope</u>. The new university was constituted by issuing notification under sub-section (2) of section 3 of the Maharashtra Universities Act, 1994.[2][3] In 27 September 2011, Gondwana University was carved out of RTMNU, Nagpur.[4] The official inauguration date was delayed until August 2012 Library is not separate building in University. At present the library has over 11710 books related to different streams. Rapid accumulation and dissemination of information is the major concern of each academic library.

# LITERATURE REVIEW

Review of related literature is very important for every research. Many scholars have surveyed to get acquainted with user information seeking behaviour and status of information sources and information services of library from user point of view. A few research works are reviewed in the present study[5].

Major findings are that many users are unaware of the resources and services. Majority of users are satisfied with information services. Maximum users visit library to borrow and return books.

Majority of researchers were found to be aware of the information services. But CAS,SDI and ILL services were not satisfactory. Users were not satisfied with the availability of journals but physical facilities were up to the mark.

It is seen that reading materials are adequate but users are not satisfied about the physical facilities of library. The users are unaware of the majority of library services. Users prefer to use books and CD –ROMs. Interestingly users use controlled vocabulary for information searching purpose.

### **OBJECTIVES**

The study was undertaken to find out the existing library and information service facilities in the Gondwana University Gadchiroli for the year 2013-2014. The specific objectives of the study are as follows :-




Figure 1 Library Users of Gondwana University Library




Figure 2 Total No. of Users in Gondwana University Library

# CONCLUSION
