Integration implementation vector of the national economic interests of Ukraine: theoretical and practical backgrounds aspects

ABSTRACT. In the article there was considered the appropriateness of optimal combining of Ukraine's economy transparency and policy of economic protectionism for the purpose of its national interest's defense.
