The main functions of the analytical unit are:

- Accounting, compilation and ongoing analysis of materials on the status of information security company (its branches and representative offices);
- Analysis of possible threats to information security, simulation of real-world scenario of possible actions of competitors (intruders), affecting the interests of the company;
- Ensuring the effectiveness of the analysis of available information, avoiding duplication with its collection, processing and dissemination;
- Monitoring the situation on the market of products, goods and services, as well as in the external environment in order to identify the events and facts that may be relevant to the enterprise;
- Ensuring the safety of their own information resources, limiting employee access to enterprise analytical information;
- Preparation of conclusions and recommendations aimed at improving the effectiveness of planned and taken measures to protect the information and clarification (correction) organizational and planning documents of the enterprise and its subdivisions;
- Make recommendations for changes and additions to the methodological documents regulating algorithm of actions to protect the employees of the enterprise information (enterprise standards).

The presence of a constant analytical work, its character and the results determine the need, the basics of organization, structure and content of a comprehensive information security requirements for its effectiveness and direction of its development and improvement. Analysis of the state information security system significantly affects the quantity, composition and structure of business units, directly address these challenges (security service companies, security service, Secrecy subdivision et al.). The efficiency and quality of doing analytical work in the company fully depends on the state of security of information resources of the enterprise classified as protected, as well as the timeliness and validity of measures to prevent leakage of confidential information and loss of media. The effectiveness of analytical work and its results are the basis for making management decisions by management in the organization of information security. - Decided to limit the publication in the press, use in advertising and publishing activities of certain materials (materials on selected topics), the access of travelers, to exclude consideration of these materials at conferences, seminars, meetings, etc.
