Abstract

The main aim of the study was to find out the Emotional Maturity and Social Intelligence of B.Ed., Students. The present study adopts normative survey method. The total sample of the study consists of 300 B.Ed., Students in and around Coimbatore district. Simple random sampling technique was adopted to collect data from the samples. Emotional Maturity and Social Intelligence tool (constructed) was administered to the Students. Data was collected from the selected area. Data was analyzed through SPSS. Descriptive and inferential analyses were carried out in relation to demographic variables. The findings of the 't' test revealed that gender, locality wise significant difference was found, 'F' test results shows that no significant difference among type of institution B. Ed Students in their Emotional Maturity and Social Intelligence.

So students were selected for the pilot study. The tools were given based on data reliability and validity of the Emotional Maturity questionnaire and Social Intelligence questionnaire were calculated for the present study.

Establishing Reliability and Validity of the Tools

❖ Reliability of Emotional Maturity Scale

In order to establish the reliability of the Emotional Maturity scale, the split half method was used. The reliability of Emotional intelligence scale was found to be 0.75. Hence Emotional Intelligence scale is considered as a reliable tool.

❖ Validity of Emotional Maturity Scale

The index of validity which is the square root of reliability was found to be 0.85. Hence Emotional Maturity scale selection for the study was considered to have high validity.

***** Reliability of Social Intelligence Scale

In order to establish the reliability of the social intelligence scale, the split half method was used. The reliability of social intelligence scale was found to be 0.79. Hence social intelligence scale is considered as a reliable tool.

***** Validity of Social Intelligence Scale

The index of validity which is the square root of reliability was found to be 0.87. Hence social intelligence scale selection for the study was considered to have high validity.

Sample

The sample of the study was selected in the following manner. A representative sample of B.Ed Students is collected from six colleges. 300 B.Ed Students were taken for the study, 100 students were drawn from Government College, 100 from Government Aided and the remaining 100 from Private College. The teacher trainees studying in B.Ed course in the Coimbatore district in Tamil Nadu were chosen as the sample.

Statistical Techniques

Suitable descriptive and inferential statistical techniques were used in the interpretation of the date to draw out a more meaningful picture of results from the collected data. In the present study the following statistical measures were used:

❖ Mean, Standard Deviation, t-test and F-test distribution.

Major Findings

Analysis of the data reveals the following findings;

- ❖ Gender shows significant difference on Emotional Maturity and Social Intelligence of the B.Ed Students.
- ❖ Type of institution shows significant difference on the Emotional Maturity and Social Intelligence of the B.Ed Students.
