THE ROLE OF SPIRITUAL PRODUCTION IN THE FORMATION OF 5-6 TECHNOLOGICAL STRUCTURE

Summary. The article is devoted to consideration of the possible reasons of non-universality of the economic theory bringing, in the conditions of

economic and political shocks, to incorrect decisions and notable social and economic losses.

Key words: *economic theory, spiritual production, personal knowledge.*

Value law that served a principal regulator of economic relations for hundred years has stopped performing this function in knowledge-based economy. Actually knowledge-based economy requires re-evaluating traditional categories and approaches and changing their content. It is well known, that knowledge is not sold and purchased, but it is produced by each person individually. Knowledge is created only in a human brain in the process of mental production. Without being necessary for a mental production, a personality, an intellect of a person, data will stay data, the storage of useless things. That is education that forms mental production of a person: his or her personality, soul, intellect. Due to this fact, education and training become the key sectors of knowledge-based economy. Market has played the subordinate role in the process of forming mental production – role of “raw materials” supplier for the production of the real treasure of the society – knowledge.

As historical experience shows, technological way

is not overcome, is not subordinated, does not sustain the spiritual matrix of a society but only imposes certain limitations on it. If the properties and content of the spiritual matrix of a society determinate effectiveness of implementation of technology within certain specifications then the effect of “resonance” – fast “deploy” of profound transformation of the productive forces and relations of production is rapidly changing (4 TU in USA and Europe). If spiritual matrix of a society does not contain required elements or contains contradictory elements, deploying of TU is happening with substantial social and economic losses, the society is changing, but not so quickly and dramatically as in the first case (4 TU in the USSR).

Requirements of 5-6 TU to spiritual matrix of a society is fundamentally different from 4 TU ones, so none objective limits for the formation of the 5-th and 6-th TU on any territory can exist; 5-th and 6-th TU may be formed in any country and region.
