## FINANCING AGRICULTURAL PRODUCTION AS A GUARANTEE FOOD SECURITY

Summary. The problem of food security in the country and the ways for its resolution and the role of

financing agricultural production as a guarantee of food security in the future.

Solving the problem of food security in the 21st century is of strategic importance because in the world in 2050 will need to feed 9 billion people.

Problems of food safety are important for Ukraine, despite its fertile soils, favorable climate and adequate development of the productive forces. As a result of irresponsible agriculture reform the state can not use its natural resources and huge production, economic and financial capacity for the benefit of its citizens. Reduction of cash income led to deregulation of the domestic market, to a catastrophic decline in consumer demand and the impoverishment of the population. According to recent statistics, 39 million Ukrainian consumes less than normal milk, 35 million – meat and vegetables; 26 million – fish and sugar; 16 million – 43 million and bread – vegetables.

Ensuring food security requires the development of a long-term strategy that involves both an increase in agricultural production and increase access to nutritious food for low-income segments of the population worldwide.

Food security is guaranteed by the measures which should be carried out on the macro and micro levels, namely at the level of individual states and agricultural enterprises.

The main source of agricultural production is its adequate and timely funding, because the financial resources are necessary to cover the costs of production and circulation, timely fulfillment of financial obligations to the state, banks and other entities, of income and profits.

Agriculture of Ukraine guarantee food security increasing constantly volume of agricultural production, but nevertheless has a number of problems for the timely provision of own financial resources and modern agricultural machinery.

For the development and efficient operation of agricultural enterprises, improving their funding is necessary to carry out a number of measures, including:

To remove intersectoral imbalances in the economy, consequently eliminating disparity in prices for resources and agricultural products and lack of compensation for reduced public investment in agricultural production influence other market mechanisms;

the government should promote equivalent exchange between agriculture and other sectors of the economy, through the mechanisms of distribution relationships to receive the same profitability in different industries and agribusiness complexes;

to improve the structure and direction of investment and financial security;

to direct investment funds for the acquisition and application of new technologies and techniques, which ultimately will improve the results of management of agricultural enterprises.
