PROGRAM TARGET METHOD AS TARGET INSTRUMENT OF THE DEVELOPMENT OF MATERIAL AND TECHNICAL BASIS OF THE SOCIAL SPHERE OF UKRAINE

Summary. Program-target method was considered as the main instrument of the social development in the future. The major government

The article is aimed at the consideration of program target method as the main instrument of the development of the social sphere for the future. This method is considered as a planning form which is focused on solving urgent problems of the material and technical support of the state's social sphere. It is suggested to use program target method as an instrument of sustainable development of the social sphere in order to improve management mechanisms of its development. The research results are generalized which indicate that program target method has significant advantages over the others and is the most effective method of state regulation.
