IMPROVED DEPOSITORY SUPPORT THE STOCK MARKET UKRAINE

During the depository system in the world to understand certain accounting and securities clearing and settlement infrastructure component securities market. This infrastructure segment is serving system performance contracts (agreements) on securities. The main depository institutions throughout the world are: depository, custody (custodians), clearing organizations, recorders.

All securities issues in Ukraine were originally made in documentary form. In 1999, p. according to the Law of Ukraine "On National Depository System and Electronic Circulation of Securities in Ukraine" was created by the National Depository of Ukraine as a central depository system link, and in 2008 – JSC "Ukrainian Securities Depository". In such circumstances, the functions of Depositary Registration duplicated.

With the adoption of the Law of Ukraine "On the Depository System of Ukraine" dated July 6, 2012, № 5178-VI began a new phase of the country's development depositary software – documentary post. The law provides that issuers of equity securities can choose only book-entry (electronic) form of existence of securities

In economically developed countries is characterized by circulation of securities of the central securities depositories and high levels of automated clearing and settlement systems. In a sample after the enactment of the new law began building and providing depository in Ukraine at the National Depository of Ukraine created CSD, and JSC «AUSD» converted at the Clearing center.

System of Depositary Registration is as follows:

- higher level Central Depository of Ukraine and the National Bank of Ukraine (on government securities);
 - average depository institutions;
 - lower level depositors.

The process of reform eliminated registrars Securities Institute. Payments for transactions concluded on the stock exchanges and outside them, carried out on a "delivery of securities against payment" leads Settlement Centre service contracts in the financial markets (Clearing center).

There is now completed implementation of the infrastructure in the analyzed securities market worldwide trend towards unification, standardization and unification. Introduced depository model meets international practice, the functions of accounting and securities clearing now divided between the relevant agencies, is a single register of holders of securities, increasing investor protection and minimizes the risk of raiding.
