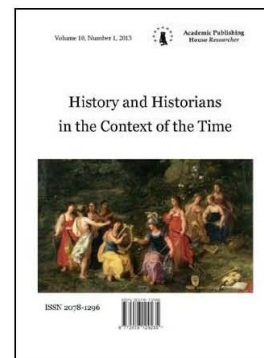

Abstract

The article gives an overview of the thirteen years of existence of the journal „History and Historians in the Context of the Time”. This paper presents retrospectives of the journal 2003 - 2016, as a testimony to their persistent work on developing and improving the quality of the content of the journal. From this presentation editorial is noticeably much commitment editor in chief Dr. Aleksandr Cherkasov and the editorial board, to present the results of current research on the history and culture of the Caucasus, as well as immeasurable scientific and professional contribution in this respect by numerous authors. In an editorial is presented and his current position and achievements "History and Historians in the Context of the Time" with Impact Factor of OAJI in 2016 is 0.351 and MIAR is 6.114. In the judgment of certain scientific of contributions in this, but also any future issue of the journal "History and Historians in the Context of the Time", it would be important to keep and thought which Journal had and has a quality that is gained to continue to be significant support to historians - researchers as a place where they can publish their research results.

In a series of set plan, Academic Publishing House Researcher creates a total of 49 scientific - professional journals. In this group, the journal "History and Historians in the Context of the Time" occupies a special place.

Namely, the mission of journal is to present the results of current research on the history and culture of the Caucasus. The priority areas for us are the historical patterns and civilization features of the Caucasus as a multinational area with a controversial history, unique historical and cultural heritage, as well as the traditions and customs of the Caucasian peoples, their experience of living together for the past two millennia. The journal's objective is to familiarize the specialists and all interested readers with the latest developments in historical and other human sciences, the

development of inter-institutional and international scientific cooperation in the framework of the scientific problems related to the history of the Caucasus (Academic Publishing House Researcher, 2016).

The journal is published in its original, modest edition in 2003 (with a break in 2008). Since its original appearance and content over time, "History and Historians in the Context of the Time" on several occasions been changing (Figure 1). It becomes more modern appearance, quality in content and in scientific - technical terms is becoming one of the most important editions of this character in the history and culture of the Caucasus. So far, a total of 16 numbers came out the Journal, and preparation for printing, there is a 17 number.

Journal „History and Historians in the Context of the Time”, publishes scientific articles that is original scientific papers (papers outlining the previously unpublished results of our own historical research scientific method; review articles (articles containing original, detailed and critical review of the research of historical problems or areas in which the author made a contribution, visible on the basis of citations); Short or preliminary communication (original scientific paper of full format, or small-scale or preliminary character); scientific criticism, or controversy (discussion on a particular scientific topic based exclusively on scientific argumentation) and review. Also, „History and Historians in the Context of the Time”, publishes expert articles, it is a professional work (attachment in which the nude experience useful for improvement of historical science, but which are not necessarily based on scientific method); informative annexes (editorial, comment...); including accounts of scientific and professional publications display cases, scientific events ...

Technically, it is noticeable the journal "History and Historians in the Context of the Time", a somewhat larger format and yes articles starting abstracts and keywords, or introduction (why it was done and what has been done?), materials and methods (what was used and how?), results (what happened and what is obtained?), discussion (what it all means?), references (which was quoted in the text?), gratitude (which has helped?), the conclusion (which are the causes and consequences), as outlined in the practice of issuing these kinds of serial publications (Rajović and Bulatović, 2016). It is possible to use a different way according to Popović (***) and Gaćeša & Jovanović (2012) which presents the handwriting, that is necessary to taken to ensure that the entire historical article contains material which should include the development of the following elements: what is the reason for working on selected historical problem?, what it was known and what was unknown before the of research and what you to indicated that the foreseen perform research? what is expected to an article displayed data or hypotheses to check?, under what conditions were conducted historical research ?, a research plan and methods, as received (were collected) historical data (results) ?, which method the results were analyzed, the results obtained?, the validity and significance of the results and the conclusions that can be drawn from them, a

comparison of the results with results from other articles, the direction of future work and references used in the work.

All articles in the journal "History and Historians in the Context of the Time", mainly containing translated summaries in two languages - Russian and English, and availability requirements of the summary not only satisfied but, bearing in mind the usual standards, and exceeded, because this journal has enabled bilingualism availability of basic ideas and attitudes of each author significantly wider circle of readers. As is typical of scientific journals, "History and Historians in the Context of the Time", contains detailed instructions for authors of the call for submission of papers. The newspaper has been and remains open to all creative and historical ideas about the culture and history of the Caucasus, present both in the Russian Federation and in the world.

According to data Academic Publishing House Researcher (2016) in previous numbers (from 02 October, 2003 to 31 March, 2016), journal „History and Historians in the Context of the Time”, is represented total of 167 articles. These articles proposed by the 186 authors from 8 countries. Besides researchers from the Russian Federation and the former space Soviet Union for „History and Historians in the Context of the Time”, for 13 years have published articles and researchers from: Slovakia, Israel, Germany. The qualities of authors' are contributions blackmailed by renowned reviewers of Russian Federation and from abroad.

Journal is indexed by: CiteFactor, Directory of Open Access Journals, EBSCO, Global Impact Factor, Google scholar, Index Copernicus, Journal Index, Journal Finder, La BIU Santé, National Research Council, Научная электронная библиотека, Open Academic Journals Index, ResearchBib, Sherpa Romeo, Toronto Public Library, Ulrich's, Universal Impact Factor. The journal is subjected to constant evaluation (monitoring) depending of influence (thief impact).
